Art Under the Tree & Ornament Competition specifications

- Art Under the Tree is a show to promote art as a Christmas gift. Artists should think "gift giving" when submitting their entries. As always, artwork must be original work. However, glass ball ornaments may be purchased for painting.
- Artwork is not juried for entry into AVA's Art Under the Tree show, or the Christmas Tree Ornament competition. The show is open to AVA members only. The ornament competition is open to anyone.
- Artists are eligible to submit up to 5 pieces of art and/or 5 ornaments. There is a \$10 entry fee for the art show. There are no charges to enter the ornament competition. AVA receives a 25% commission fee on all art sales, (except ornaments) so price your art entries accordingly. Please include your \$10 *Art Under the Tree* entry fee with your entry form.
- *Art Under the Tree* will open Friday, December 7 with an evening reception from 5 p.m. to 7 p.m. The ornaments will be hung on a tree in the gallery prior to the reception. A people's choice vote will determine both the *Art Under the Tree* and ornament competition winner. Winners will receive cash awards determined by the number of entries.
- Artwork should be suitably matted/mounted, framed under glass or Plexiglas, and be properly wired, ready to hang. **No saw tooth hangers will be permitted. Place a label on the back of your artwork, or a hang tag on your ornaments. Include your name, artwork/ornament title & price.**
- Information from the art entry form is used for multiple purposes such as inventory lists and price tiles. Therefore, we ask that you make no changes or substitute other artwork once the form is submitted.
- Ornament identification hang tags are the responsibility of the artist.
- An Antigo Visual Arts *AVA Release and Waiver of Liability* form (*included*) must be on file with AVA before any artwork or ornament will be accepted. **If you have previously completed this form it does not need to be submitted again.**
- **NOTE:** Any artwork or ornaments left at the museum 30 days past the scheduled pick-up date become the property of Antigo Visual Arts. Exclusions include greeting cards & artwork in the unframed artwork caddy.
