#### AVA judged art show specifications

- Artwork is not juried for entry into judged shows at the AVA Gallery. All artists 15 and older are welcome to enter their artwork in this show.
- Artists are eligible to submit up to 5 pieces of art.
- **SHOW FEES:**  
AVA members in good standing. . . \$5 per entry up to five (5) entries.  
Artists who are not members of AVA . . . \$10 each for the first two (2) pieces submitted, and \$5 each for additional entries, up to a total of five (5) entries. *Please include your entry fee with the submission of this form.* AVA receives a 25% commission fee on all sales, so price your entries accordingly.
- An AVA membership form is included should you choose to join AVA when you submit your show form. Becoming an AVA member at this time entitles you to AVA member entry fees.
- Artwork can be paintings, sculpture, photography, mixed media, pottery, textiles, woodworking, wood carving, monoprints.
- Artwork must not have been shown before, at the AVA Gallery unless arranged ahead of time with AVA Gallery Director Karen Aulik-Now.
- Entries must be original works of art, entirely the work of the entrant.
- Artwork should be suitably matted/mounted, framed under glass or Plexiglas, and be properly wired, ready to hang. *No saw tooth hangers will be permitted.* Place a label on the back of your artwork with your *name, artwork title & price.* **NFS (Not For Sale) items will not be accepted.**
- Information from the entry form is used for multiple purposes such as inventory lists and price tiles. Therefore, we ask that you make no changes or substitute another artwork once the form is submitted.
- An Antigo Visual Arts AVA Release and Waiver of Liability form (*included*) must be on file with AVA before any artwork will be accepted. *If you have previously completed this form it does not need to be submitted again.*
